NOTICE OF EXPRESSION OF INTEREST FOR APPLICATION TO THE PARAMETERIZATION COMMISSION FOR THE CTT-T, LIVIGNO (SO), DECEMBER 4-5, 2025

It is hereby announced that, following D.D. No. 6876 of 13/05/2025, the framework agreement between the Calabria Region and the Regional College of Ski Instructors of Calabria has been approved for the organization and implementation of the Common Training Test (CTT-T), to be held in Livigno (SO) on December 4 and 5, 2025, with a possible make-up day scheduled for December 6, 2025.

This notice opens the application process for the selection of at least three (3) forerunners (pace setters) who will make up the dedicated Parameterization Commission.

Art. 1 Eligibility Requirements

Applicants must meet the following criteria:

- Hold Italian citizenship or that of another European Union Member State;
- Be included in the list of “pace setters” established during the test held on January 14–15, 2025, in Limone Piemonte;
- Hold a valid professional liability insurance policy (RCT).

Art. 2 Financial Conditions

For the professional service covered by this notice, a specific appointment will be issued by the Regional College of Ski Instructors of Calabria.

- For Italian pace setters, compensation will consist of a daily allowance of €400, inclusive of all tax charges. In addition, a travel reimbursement will be provided at a rate of €0.35 per km, calculated from the place of residence to the place of service. This reimbursement is considered to include all travel-related expenses.

For pace setters residing more than 250 km from the event location, the travel day will be considered as a working day for all purposes.

- For pace setters from other EU Member States, compensation and expenses related to travel, meals, and accommodation will be borne by their home country.
