## **NOTICE OF EXPRESSION OF INTEREST**

### **CALL FOR EXPRESSIONS OF INTEREST FOR THE SELECTION OF MEMBERS OF THE CTT-T EXAMINATION COMMISSION WITHIN THE FRAMEWORK DEFINED BY DELEGATED REGULATION (EU) 2019/907 OF 14 MARCH 2019 AND SUBSEQUENT AMENDMENTS – ANNEX 2**

**HAVING** regard to Article 2 of Delegated Regulation (EU) 2019/907 and subsequent amendments, which establishes the content of the Common Training Test (PFC) and the conditions to be met both to take part in and to pass it;

**CONSIDERING** Article 8 of Regulation 2019/907, as amended by Commission Delegated Regulation (EU) 2023/865 of 23 February 2023, stating that “*ski instructors who have successfully passed the aforementioned CTT or who enjoy acquired rights pursuant to Article 7 of Delegated Regulation 2019/907 shall be issued a certificate of competence through the Internal Market Information System (IMI) established by Regulation (EU) No 1024/2012, by a competent authority in a Member State*”;

**TAKING INTO ACCOUNT** that, as indicated in Annex I to the aforementioned Regulation, as amended by Delegated Regulation (EU) 2023/865 of 23 February 2024, in Italy the competent authorities include, among others, the Regions and the Autonomous Provinces of Trento and Bolzano, which, pursuant to recital (8), “*have exclusive competence to issue the qualification of ‘Ski Instructor’ and may delegate this power to other Italian bodies listed in Annex I to Delegated Regulation (EU) 2019/907*”;

**TAKING INTO ACCOUNT** that the Common Training Test is a standardized aptitude test available among participating Member States and reserved for holders of specific professional qualifications. In accordance with Article 49 ter, paragraph 1, of Directive 2005/36/EC, passing the test in one Member State entitles the holder of a given professional qualification to pursue the profession in the host Member State under the same conditions applicable to holders of qualifications obtained in that Member State;

**TAKING INTO ACCOUNT** that, pursuant to point 1.2.3 of Annex II to Delegated Regulation 2019/907, the course must be approved by a “**technical commission**”, whose members are to be appointed by the organizing Member State or, where appropriate, by the competent authority, based on their competence and professional experience. Member States or competent authorities other



than the one organizing the CTT may propose members for the technical commission. In such cases, the organizing Member State or competent authority may refuse a proposal only for duly justified reasons;

**TAKING INTO ACCOUNT** the document drawn up by the Coordinators Group for Directive 2005/36/EC on 24 June 2025, which is hereby fully referenced, from which it appears that eligibility for membership in the “**Technical Commission**” requires:

- EU citizenship (preferential requirement);
- Appointment based on competence and professional experience;
- Passing the CTT is not mandatory;
- Preference should be given to holders of qualifications listed in Annex I to Regulation 2019/907;

**TAKING INTO ACCOUNT** that, pursuant to point 1.1.4, first indent, of Annex II to Delegated Regulation 2019/907, examination commissions supervise and ensure the proper conduct of the technical test, and that membership in the examination commissions is open to qualified citizens of all Member States. Therefore, only citizens who passed the Eurotest before the entry into force of the aforementioned Regulation or who have passed the CTT may be appointed as members of the examination commission for evaluating the technical test modules;

**TAKING INTO ACCOUNT** the document prepared by the Coordinators Group for Directive 2005/36/EC on 24 June 2025, which states that eligibility for membership in the “**Test Juries**” requires:

- Citizenship of an EU Member State (including EFTA/EEA citizens and third-country nationals with equal treatment, e.g., long-term residents or seasonal workers);
- Holding a qualification listed in Annex I to Regulation 2019/907;
- Having passed the Eurotest prior to the entry into force of the Regulation or having passed the CTT;

**CONSIDERING** that, according to the same document, instructors benefiting from automatic recognition of acquired rights are **not automatically eligible** to serve as examiners unless they have passed the relevant tests (CTT, Eurotest, or Eurosecurity) before the Regulation entered into force;



**CONSIDERING** that Article 6(2) of Law No. 81 of 8 March 1991, which provides that the training courses for the qualification of ski instructors are organized by the Regions in collaboration with regional and provincial professional colleges, as well as with the technical bodies of the Italian Winter Sports Federation, under the conditions set by regional legislation;

**CONSIDERING** that D.D. No. 6876 of 13/05/2025 approved the agreement between the Calabria Region and the Regional College of Ski Instructors of Calabria for the organization and implementation of technical, educational, and cultural courses for qualification as ski instructors under Law No. 81/1991 and Delegated Regulations (EU) 865/2023 and 907/2019;

**CONSIDERING** that, with D.D. No. 15338 of 30/10/2024, the draft agreement between the Calabria Region and the Regional College of Ski Instructors of Calabria was approved for the organization and implementation of the common training tests and the appointment of the test juries and the technical commission in accordance with the framework defined by Delegated Regulation (EU) 2019/907 of 14 March 2019;

**CONSIDERING** that, pursuant to point 1.1.4, second indent, of Annex II to Delegated Regulation 2019/907, such test juries are designated by the organizing Member State or, where appropriate, by the competent authority based on their professional competence and experience in the field. The organizing Member State or competent authority may delegate this power of appointment to third parties, but members of the test juries must always represent at least three Member States.

**HAVING** Law No. 81 of 8 March 1991 (“Framework Law for the Profession of Ski Instructor and further provisions regarding the Alpine Guide profession”);

**CONSIDERING** that the Regional College of Ski Instructors of Calabria intends to conduct the CTT T on 4–5 December 2025 in Livigno (SO), with 6 December reserved as a possible recovery day;

**CONSIDERING** the interest of the Regional College of Ski Instructors of Calabria in proceeding with the appointment of both the technical and examination commissions;

**THE PRESIDENT OF THE REGIONAL COLLEGE OF SKI INSTRUCTORS OF CALABRIA**

**HEREBY ANNOUNCES THAT**

A call for expressions of interest is launched for the identification of a pool of candidates from which the **Technical Commission** and the **Test Juries** for the Common Training Test CCT-T will be established, in accordance with the criteria set out in points 1.1.4 and 1.2.3 of Annex II to Delegated Regulation (EU) 2019/907.

**Art. 1**

**(Purpose of the activity)**

With this notice, the Regional College of Ski Instructors of Calabria intends to carry out a market survey aimed at identifying suitable profiles for the composition of the Test Juries and the Technical Commission for the CTT-T, in compliance with the requirements set out in points 1.1.4 and 1.2.3 of Annex II to Delegated Regulation (EU) 2019/907.

**Art. 2**

**(Prerequisites)**

1. To submit an application under this notice, candidates must, on the date of submission, meet the following prerequisites:

**(a) General requirements for both commissions:**

- i. Enjoy full civil and political rights;
- ii. Have no criminal convictions resulting in disqualification from the practice of the ski instructor profession and not be subject to preventive measures, civil judgments, or administrative provisions entered in the criminal record;
- iii. Have no pending criminal proceedings;
- iv. Have no ongoing civil or administrative disputes and not be a party to any legal proceedings against the Regional College of Ski Instructors of Calabria or any other regional or provincial College.



**(b) For the Technical Commission:**

- i. Preferably be a citizen of any EU Member State;
- ii. Preferably hold a professional qualification listed in Annex I to Delegated Regulation (EU) 2019/907;
- iii. Possess proven professional experience and competence in the management and use of ski slopes, to be demonstrated by submitting a curriculum vitae.

**(c) For the Test Juries:**

- i. Be a citizen of Italy or of any EU Member State, including citizens of EFTA/EEA countries or third-country nationals enjoying equal treatment (e.g. long-term residents, seasonal workers);
- ii. Hold a professional qualification listed in Annex I to Delegated Regulation (EU) 2019/907, as evidenced by a copy of the qualification or IMI registration certificate;
- iii. Have passed the Common Training Test (PFC) or the Eurotest prior to the entry into force of the Regulation, as evidenced by appropriate certificates or IMI attestation;
- iv. Hold professional liability insurance coverage for their professional activity.

2. The possession of these requirements and the absence of exclusion grounds must be certified through a self-declaration made pursuant to Presidential Decree No. 445/2000, signed under the applicant's personal responsibility and with full legal effect, acknowledging the criminal penalties applicable in the event of false statements.

This declaration must be attached to the application form: **MODEL "A1"** for the "Technical Commission" and **MODEL "A2"** for the "Test Juries"



### **Art. 3**

#### **(Composition of the Commissions)**

1. For the **“Technical Commission”**: following the collection of applications and verification of the effective possession of the eligibility requirements referred to in Article 2 of this notice of expression of interest, the College will proceed to appoint the Technical Commission, which will have the following composition:
  - (a) n. 1 President, appointed by the Regional College (non-voting), who may lack the requirements set out in Article 2, paragraph (b), points i, ii, iii;
  - (b) n. 1 Secretary, appointed by the Calabria Region from among the officials of the competent Department, pursuant to Article 7 of Agreement No. 23099 of 05/11/2024 between the Calabria Region and the Regional College of Ski Instructors of Calabria (non-voting), who may also lack the same requirements;
  - (c) n. **3 Technical Members (voting)** possessing the requirements set out in Article 2, paragraph (b), points i, ii, iii.
  
2. For the **“Test Juries”**: following the collection of applications and verification of eligibility under Article 2 of this notice, the College will appoint the Test Juries, composed as follows:
  - (a) n. 1 President, appointed by the Regional College (non-voting), who may lack the requirements set out in Article 2, paragraph (c), points i, ii, iii, iv;
  - (b) n. 1 Secretary, appointed by the Regional College (non-voting), who may lack the same requirements;
  - (c) n. **5 Technical Members (voting)** meeting the requirements set out in Article 2, paragraph (c), points i, ii, iii, iv — **two (2)** of whom shall come from EU (or equivalent) Member States other than Italy.



#### **Art. 4**

##### **(Duration of the appointment)**

The appointment shall be valid for the duration of the test, scheduled for 20 and 21 April 2026, with the Commission convened on 19 April 2026 at 18:30. The Commission is convened at the Intermonti Hotel. The validity may be extended to 22 April 2026 for possible recovery.

#### **Art. 5**

##### **(Location of the assignment)**

The CTT-T will take place on 20 and 21 April 2026 in Livigno, with 22 April 2026 reserved as a recovery day.

#### **Art. 6**

##### **(Application procedure)**

1. Interested applicants must submit their applications exclusively using the attached forms “Model A1” and “Model A2”, **no later than 30 March 2026**, to the following addresses:

2. Applications received after the deadline will not be considered. Candidates may apply for one or both commissions.

#### **Art. 7**

##### **(Financial terms)**

1. For the professional services covered by this notice, a specific appointment will be issued by the Regional College of Ski Instructors of Calabria.
2. **For Italian members**, the compensation will correspond to the daily allowance established by the Board of Directors of the Regional College of Ski Instructors of Calabria.  
Travel expenses will also be reimbursed at **€0.35/km**, calculated from the place of residence to the venue, inclusive of all related costs.



3. **For members from other EU countries**, compensation and travel, board, and lodging expenses will be borne by their home State.

**Art. 8**  
(Data protection)

Personal data provided by applicants will be processed in full compliance with the provisions of the GDPR and Legislative Decree No. 196/2003, as amended by Legislative Decree No. 101/2018.

**Art. 9**  
(Publication)

1. A copy of this notice will be published on the “Transparent Administration – Calls and Competitions” section of the official website of the Calabria Regional College and on the official website of the National College of Ski Instructors.
